HAWAII-SOUTHERN CALIFORNIA TRAINING AND TESTING DRAFT ENVIRONMENTAL IMPACT STATEMENT/OVERSEAS ENVIRONMENTAL IMPACT STATEMENT AVAILABLE FOR PUBLIC REVIEW AND COMMENT

[HONOLULU] — The U.S. Navy has prepared a Draft Environmental Impact Statement/Overseas Environmental Impact Statement (EIS/OEIS) to re-evaluate potential environmental impacts associated with ongoing military readiness activities, which include training and research, development, testing, and evaluation activities (hereafter referred to as "training and testing") conducted within the Hawaii-Southern California Training and Testing (HSTT) EIS/OEIS Study Area (hereafter referred to as the "Study Area"). The Navy welcomes the public's review and substantive comments on the Draft EIS/OEIS.

The Navy prepared the Draft EIS/OEIS to support the issuance of federal regulatory permits and authorizations under the Marine Mammal Protection Act and the Endangered Species Act. The Navy previously completed an EIS/OEIS in December 2013 for training and testing activities occurring within the Study Area from 2013 to 2018; this updated analysis will support future activities beginning in 2018. In this Draft EIS/OEIS, the Navy evaluates new, relevant information, such as more recent marine mammal density data and new scientific information, and updates environmental analyses as appropriate.

Proposed Action:

The Proposed Action is to conduct Navy training and testing activities within the Study Area. These activities include the use of active sonar and explosives while employing marine species protective mitigation measures. Proposed training and testing activities are similar to the types of activities that have occurred in the Study Area for decades. The purpose of the Proposed Action is to maintain a ready force, which is needed to ensure the Navy can accomplish its mission to maintain, train, and equip combat-ready naval forces capable of winning wars, deterring aggression, and maintaining freedom of the seas, consistent with Congressional direction in Section 5062 of Title 10 of the U.S. Code.

To achieve and maintain military readiness, the Navy proposes to:

- Conduct training and testing activities at levels required to support Navy military readiness requirements beginning in 2018; and
- Accommodate evolving mission requirements, including those resulting from the development, testing, and introduction of new vessels, aircraft, and weapons systems into the fleet.

The Study Area consists of the at-sea areas off the coasts of Hawaii and Southern California, areas on the high seas between the Navy's Hawaii and Southern California range complexes where training and testing may occur during vessel transit, the Temporary Operating Area north and west of the Hawaii Range Complex, and select Navy pierside and harbor locations.

Public Meetings:

The Navy is holding five public meetings, four on Hawaii and one in Southern California, to provide information and an opportunity for the public to comment on the Draft EIS/OEIS. Public meetings will include an open-house information session, during which time Navy representatives will be available to provide information and answer questions. A Navy presentation and public oral comment session will occur during the meetings. Written and oral comments will be accepted throughout each public meeting.

Concurrent with the National Environmental Policy Act public involvement process, the Navy is conducting National Historic Preservation Act section 106 consultations regarding potential effects of the Proposed Action on historic properties. Historic properties include districts, sites, buildings, structures, or objects listed or eligible for listing in the National Register of Historic Places. During each of the meetings, an information station will be available, where subject matter experts will explain the section 106 process and solicit public input.
