

6 Purpose/Need/Scope State purpose of proposed activities:

Purpose: to explore the nature of the wildlife in the course of the tours offered , to learn the current problems the wildlife is having on Midway so that we can understand better what is going on, to learn about the conservation methods, help in conservation (e.g. by cleaning beaches, pick up trash while on tour) and explore the possibilities of raising funds for the monument

7. Answer the Findings below by providing information that you believe will assist the Co-Trustees in determining how your proposed activities are compatible with the conservation and management of the natural, historic, and cultural resources of the Monument: All planned excursions will be done in cooperation and after aproval by the field staff.

The Findings are as follows:

a. How can the activity be conducted with adequate safeguards for the cultural, natural and historic resources and ecological integrity of the Monument?

All the rules and regulations of the monument will be strictly adhered to. The personnel will be briefed prior to arrival on the island and again by one of your rangers immediately after arrival. All clients will be informed by their tour guide that they will have to respect cultural, natural and historic resources including the rules and regulations of the monument

b. How will the activity be conducted in a manner compatible with the management direction of this proclamation, considering the extent to which the conduct of the activity may diminish or enhance Monument cultural, natural and historic resources, qualities, and ecological integrity, any indirect, secondary, or cumulative effects of the activity, and the duration of such effects? We will take all the information that your guides impart to us so we could better communicate to the outside world the need and conditions of this monument and its meaning to the world as well as to the Hawaiians. Our groups will also be willing to assist you with some of your needs if requested.

c. Is there a practicable alternative to conducting the activity within the Monument? If not, explain why your activities must be conducted in the Monument.

Midway is not only geologically exceptionel but also unique in providing breeding habitat for some of the worlds most endangered seabirds as well as mammal species (e. g. Laysan and Black-footed Albatros, Hawaiin monk seal). Apart from that we are well aware that Midway is - and has been for a long time - also a sacred place for Hawaiian people.

d. How does the end value of the activity outweigh its adverse impacts on Monument cultural, natural and historic resources, qualities, and ecological integrity?

The benefit of the knowledge you have imparted to us will add to our copious notes and fotografs we will have taken, better enabling us to have a better series of lectures attending to Midway and its rich and rare wildlife.

e. Explain how the duration of the activity is no longer than necessary to achieve its stated purpose.

A week we consider a minimum amount of time to fully understand and appreciate the functioning and purpose of the Monument, to learn about the nature of its wildlife as well as its historical and cultural meaning to the Hawaiians as well as to the rest of the world.

f. Provide information demonstrating that you are qualified to conduct and complete the activity and mitigate any potential impacts resulting from its conduct.

We are conducting nature study tours since 1980 and use our experience to design our tours. Our special traines naturalist tourguides guide and control our guests.

g. Provide information demonstrating that you have adequate financial resources available to conduct and complete the activity and mitigate any potential impacts resulting from its conduct. The tours are all inclusive and prepaid. Also are all members of the tour group individually covered by an insurance that includes extracting them from the aforsaid premisses (proof of travel insurance inclusive of general liability insurance will be submitted upon our confirmation of clients).

h. Explain how your methods and procedures are appropriate to achieve the proposed activity's goals in relation to their impacts to Monument cultural, natural and historic resources, qualities, and ecological integrity.

As there will be only binoculars and cameras used, all rules and regulations will be adhered to and all meals will be held in your facilities to the best of our knowledge we do not forsee any impact on the Monument.

i. Has your vessel has been outfitted with a mobile transceiver unit approved by OLE and complies with the requirements of Presidential Proclamation 8031? We arrive and depart with Maritime Air and trust they fullfill all requirements

j. Demonstrate that there are no other factors that would make the issuance of a permit for the activity inappropriate.

We will only do permitted excursions and follow the advices of the guides as well as the regulations. Before starting to the trip, all guests will be briefed and on spot they will be guided by our naturalist guide.
