a.) The proposed activity would... The objective of this activity is to provide Native Hawaiians with access to culturally significant materials that can be utilized for traditional practices. By using salvaged migratory seabird specimens (MoIr & Ka'upu), this activity aims to promote sustainability and conservation education among the Native Hawaiian community. Through the utilization of these materials for tattoo tools, individuals can further explore and express their cultural heritage, fostering a stronger connection to their genealogy and historical traditions.

This would include determining the most appropriate techniques for collection, handling, and transportation to minimize any potential damage to the cultural artifacts. Given the importance of timely utilization of the MoIT and Ka'upu, careful coordination of logistics would be crucial. As a Traditional Native Hawaiian Practitioner, I would aim to continue to establish good rapport with community allowing for them to hone a greater connection with their genealogy and with that the results of this project I shall publish findings for Papahānaumokuākea with the relevant information gathered in academic journals and present them at the end of the proposed activity. This would contribute to the knowledge base of traditional Hawaiian tattooing practices, conservation efforts, and the importance of preserving cultural artifacts on and in Papahānaumokuākea.

By salvaging and utilizing the feathers and bones from deceased birds, this practice would avoid any alteration or disruption to the current bird populations within the monument. This ensures the protection and preservation of the avian species that inhabit the area. As an essential part of the process, each person participating in the traditional tattooing procedure would be educated on the significance of Papahānaumokuākea, including its importance as a protected area for migratory birds such as and not limited to the Molr and Ka'upu. This educational component would raise awareness and promote the conservation efforts of the monument. Traditional Hawaiian tattooing is not only an art form but also holds immense cultural and historical significance. By using feathers and bones from migratory birds, this practice helps to preserve and revive traditional cultural practices that have been passed down through generations. The gathering of these deceased birds for cultural and educational purposes ensures that no harm is done to live bird populations within the monument (until further research is done following this proposed activity). This approach aligns with the principles of sustainability and responsible harvesting, allowing for the continuation of cultural practices without negatively impacting the environment or bird populations. This activity creates an opportunity for collaboration between Native Hawaiian practitioners and the management of the Papahānaumokuākea Monument (CWG). By incorporating traditional practices into the preservation efforts of the monument, so that there is a continuous opportunity for shared knowledge and mutually beneficial partnerships that support the objectives of both conservation and cultural preservation.

Other information or background:

As a native Hawaiian practitioner, I have been fortunate to learn the art of traditional Hawaiian tattooing from my teacher, Vaughn Victor. Since the 1990s, He dedicated himself to the traditional methods and practices under Keone Nunes' guidance. In 2016, he started teaching me the ancient art of Hawaiian tattooing, ensuring that the knowledge and skills are preserved and passed onto future generations.

The mentor ship and lineage in traditional Hawaiian tattooing are essential aspects of this art form. The connection between Vaughn Victor and myself highlights the significance of this direct lineage. It ensures the authenticity and cultural context of this ancient technique are upheld, providing a living link to our heritage.

Under Vaughn's guidance, I have the privilege of becoming part of this living tradition and contributing to the preservation and revitalization of Hawaiian tattooing. Additionally, my research and participation in traditional practices, such as utilizing feathers and bones from migratory birds for tattooing implements, will enrich the knowledge base of Hawaiian tattooing. Although we currently use hippo tusk for our implements, traditionally, migratory bird bones were used, and understanding these practices adds depth to our understanding of the cultural significance of Hawaiian tattooing. 

Within this monument, native Hawaiian practitioners have a unique opportunity to legally access these birds for traditional practices. The significance of Papahanaumokuakea as both a cultural and ecological treasure cannot be overstated. By conducting research in accordance with the regulations set forth by Papahanaumokuakea Marine National Monument, I contribute to the preservation of traditional Hawaiian tattooing practices. Simultaneously, this research fosters a deeper connection between individuals and their roots - their genealogy, culture, and land. It is through the proper collection and utilization of MoIr and Ka'upu that we honor the cultural significance of these birds and promote a sense of cultural identity. 
The reason for the length of the activity is due to me not going personally to the Monument. And the certain amount of time it will take to gather and send the specimens to me on the main Hawaiian Island.

Furthermore, the activity demonstrates sustainable harvesting practices by only utilizing deceased birds that have been lawfully acquired for scientific or educational purposes. This approach aligns with the principles of responsible harvesting, ensuring that no harm is done to live bird populations within the monument. By practicing sustainability, the activity supports the long-term preservation of the monument's resources and maintains the ecological integrity of the Northwestern Hawaiian Islands. Finally, the activity promotes collaboration between Native Hawaiian practitioners and the management of the Papahānaumokuākea Marine National Monument. By using feathers and bones from migratory birds, practitioners are able to connect with the natural environment and honor the cultural significance of these resources. This connection to the natural world and the traditional practices of their ancestors helps to strengthen the ancestral connections of Native Hawaiians to the Northwestern Hawaiian Islands. By engaging in this activity and incorporating the feathers and bones into their tattooing tools, practitioners are actively preserving and reviving traditional techniques and practices. 8. Procedures/Methods:

These procedures are conducted with utmost respect for the cultural significance of the practice. The steps involved in this ceremony include: The ceremony begins with appropriate preparations, including selecting a suitable location that is considered sacred and appropriate for conducting the ceremony. Practitioners clean and purify themselves before proceeding with the ceremony. The designated volunteers, will gather the molt and kaupu specimens from the Papahānaumokuākea Marine National Monument. This process is conducted in accordance with the regulations and guidelines of the monument to ensure sustainable and responsible harvesting practices. The ceremony is initiated with prayer (pule) and chant (oli). These invocations offer respect, gratitude, and reverence to the birds and their species and seek blessings for the gathering and utilization of their remains. Using traditional tools, such as specialized knives and blades, the practitioner carefully segments the birds into specific parts, separating the bones from the feathers. The utmost care is taken during this process to ensure the preservation and respect of the remains. Throughout the segmentation process, chanting (oli) is performed. The chants serve as a means of connecting with the spiritual and ancestral realms and infusing the remains with energy and sacredness. Once the segmentation process is complete, the bones and feathers are meticulously preserved and stored in appropriate containers or vessels to maintain their integrity and prevent any damage or degradation. The bones and feathers are then utilized to create traditional tattooing tools. The bones may be shaped, polished, and attached to wooden handles to create specialized tools for tattooing. Feathers may be used for decorative purposes or incorporated into the tools to enhance their cultural significance. Throughout the ceremony, practitioners maintain the utmost respect and reverence for the birds and their remains. The process is carried out in a manner that aligns with the cultural protocols and traditions associated with traditional Hawaiian tattooing. The chanting, prayers, and careful handling of the remains ensure a deep and meaningful connection with the birds and their species.
